Thank you for your email. We apologize for the inconvenience caused by us mistakenly referring to an obligation on CYTA to offer wholesale central access on optical network in market 3b. An amended Commission decision will be uploaded on CIRCABC shortly.

Regarding your questions as to the notification of the cost model, please note that the cost model requires a "normal" notification to the Commission under Article 7 of the Framework Directive which needs to be uploaded on CIRCABC. With regard to the Commission Decision concerning Cases CY/2016/1882-1883, we would like to:

- (a) note that we have not imposed any obligation on Cyta [Case CY/2016/1883] to offer wholesale central access on optical network. This is verified and explained by our notification document in paragraphs 3.3.3 (p.28), 3.6 (p.35) and 5.4.2 A and B (p.57-58)
  
- (b) request your guidance concerning a point you raise in your Decision [concerning Cases CY/2016/1882-1883], page 9 (English version) where you state that *“The relevant pricing decision is planned to be notified under the Article 7 consultation procedure in the fourth quarter of 2016. The Commission acknowledges this and invites the OCECPR to **notify** the specification of the costing model without undue delay”*. Could you please indicate :
  - (i) How you expect the ‘notification of the specifications of the costing model to be done? (via circa, email, etc?)’, and
  - (ii) (depending on your answer in (i) )

How you expect OCECPR to link the ‘notification of the specifications of the costing model’ with the notification [Cases CY/2016/1882-1883] already submitted.
